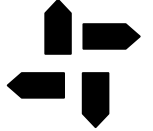

  2. To be eligible for contract award, the successful bidders shall be currently registered with the **Construction Industry Development Authority (CIDA former ICTAD)** in above mentioned grades for **Highways** specialty

  4. **Pre-Bid Meeting** is scheduled to be held on **21.07.2023** at **10.00** hrs at the Provincial Director’s Office (Sabaragamuwa), Road Development Authority, Ratnapura via Zoom and the zoom link will be provided before the meeting.
  5. It is Mandatory for bidders to register under public contracts act no.03 of 1987. For each contract (for contract value is more than 5 million) separately.
  6. A complete set of bidding documents in English language may be purchased by interested bidders on the submission of written application and ICTAD book from following offices.

    - b. Chief Engineer (Kegalle)’s Office, Road Development Authority, Kegalle
- Bidding documents will be issued from **11.07.2023 until 25.07.2023** from **9.00 hrs. to 15.00 hrs.** upon payment of a nonrefundable tender fee of **Rs.3000/=** for each document (Excluding VAT).

Bids mentioning the name on top left hand corner with separate envelopes shall be delivered in duplicate by registered post or hand to the “The Chairman, Provincial Procurement Committee (SAB), Road Development Authority, Ratnapura”, **on or before 10.00 hrs. On 26.07.2023. late bids will be rejected.** Bids will be opened soon after closing.
  8. **Bids shall be valid up to 11.10.2023**

9. All bids shall be accompanied by a **Bid Security** as mentioned in the above table and it shall be **valid up to 08.11.2023**.
