The method of payment will be in cash. As per the **Public Contract Act No. 3 of 1987**, the **agent and Successful winners of the tender shall be registered in the Department of Registrar of Companies**.

Bid shall be delivered in duplicate to the Chairman, Road Development Authority Procurement Committee, C/o **Director General's Office, 1st Floor, "Maganeguma Mahamedura, No.216, Denzil Kobbekaduwa Mawatha, Battaramulla** on or before **14:00 hrs** on **2023.08.14**.
