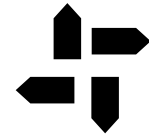

A complete set of bidding documents in English language may be purchased by interested bidders on the submission of written application and **registration form the Department of the Registrar of companies** to the provincial Director (NWP), Road Development Authority, Puttalam Road, Kurunegala from **31.08.2023 until 12.09.2023** from **9.00** hrs. to **15.00** hrs. upon payment of a non-refundable Tender fee for the document as above Table (Excluding **VAT**).
7. **As per the Public Contract Act No.03 of 1987, the bidders shall be registered in the Department of Registrar of Companies.**

Bids mentioning the name of the Contract on top left-hand corner with separate envelopes shall be delivered in duplicate by registered post or hand to the "The Chairman, Provincial Procurement Committee (NWP), Road Development Authority, Puttalam Road, Kurunegala", on or before **14.00** hrs. On **13.09.2023** late bids will be rejected.
