A complete set of Bidding Documents may be purchased by the interested bidders during the period from 07.09.2023 to 25.09.2023, from 09.00 am to 03.00 pm on the submission of a written application to the concerned Provincial Director of Road Development Authority along with a non-refundable fee of Rs.2,000.00 (Excluding Tax).

3. Bidding documents can be inspected during office hours without payment at the Additional Provincial Director's Office (East-Akkaraipattu), Road Development Authority.
4. The Pre-Bid Meeting is scheduled to be held on 15.09.2023 at 10. 00 am at Additional Provincial Director's Office (East-Akkaraipattu).
5. Bid should be valid for 91 calendar days from the date of closing bids and each bid must be accompanied by a Bid security of the value shown in the Bidding Documents and it must be valid up to 23.01.2024. Bids without a valid Bid security will be rejected.
6. Allowing to rent charges for parking vehicles in the road reserves adjacent to roads in APD's Division (East-Akkaraipattu): "RDA/DPR/SPFC/2023/41/EP(AKK)/01-03" should be mentioned on the top left corner of the envelope containing the bidding papers.
7. Completed bids with two copies may be hand delivered to the Provincial Director's Office (East-Akkaraipattu) on or before 02.00 p.m. on 26.09.2023. Late bids will be rejected. The bids will be opened soon after the closing, in the presence of the bidder's representatives.
8. The final decision rests with the tender committee of the Additional Provincial Director's Office (Akkaraipattu) of the Road Development Authority.
