**PROVISION OF SECURITY SERVICES FOR “MAGANEGUMA MAHAMEDURA” RDA

The Chairman, Road Development Authority Procurement Committee on behalf of Road Development Authority invites sealed bids from eligible and qualified bidders for provision of security service for Maganeguma Mahamedura, Road Development Authority for the period of one year.

Executing agency will be the Road Development Authority.

Bidding will be conducted through the national Competitive Bidding Procedure.

Complete set of bidding documents shall be purchased by interested bidders on submission of a written application to the **Director, Procurement Division, Road Development Authority, 4th floor, “Maganeguma Mahamedura”, No. 216, Denzil Kobbekaduwa Mw, Koswatta, Battaramulla from 11.09.2023 until 02.10.2023 during office hours on 9:00 a.m. to 3.00 p.m.** upon payment of a non-Refundable Tender fee of **Rupees. 4,600.00 (Inclusive of VAT) per one document** by depositing to the Bank of Ceylon – Corporate Branch Account Number 0000001943 in favor of Director General, Road Development Authority for contract. The original payment slip should be produced when purchasing the Bid Documents. As per the public contract act.no.3 of 1987, the agent and successful winners of the tender shall be registered in the Department of Registrar of companies. **Bid received will be closed at 2.00 p.m. on 03.10.2023.**

Bidders are required to submit the following documents along with the bids.

- (a) Documentary proof for maintaining at least a Security Services Contract where the contract sum is not less than Rs. 500,000/- per month during the past 05 years.
- (b) Certified copies of deposits of EPF & ETF for the last 02 years.
- (c) Copies of receipts of VAT payments for the last 02 years.
- (d) List of Security Services contracts in hand with the number of staff deployed in each contract and contact numbers.

Bid shall be valid up to **91 calendar days** from the date closing of the Bid.

Bids must be accompanied by a **Bid security (Valid up to 09/02/2024) for the amount of Rs. 350,000.00.** Any Bid not accompanied by a valid Bid Security will be rejected.

Sealed bid may be dispatched either by registered post or hand delivered in **duplicate** to the **Chairman, RDA Procurement committee, Road Development Authority, 1st floor, Maganeguma Mahamedura, No.116, Denzil Kobbekaduwa Mw., Koswatta, Battaramulla** to receive before the closing time. Please indicate **“Security Service for “Maganeguma Mahamedura”** on top left hand corner of the envelope.

The bids will be opened immediately after the closing of bids at the office of the **Director, Procurement Division, Road Development Authority, 4th floor, Maganeguma Mahamedura, No.116, Denzil Kobbekaduwa Mw., Koswatta, Battaramulla.** Bidders or their authorized representatives are requested to be present at the time of opening.
