- Bidding documents will be issued from 20th March 2024 until 02nd April 2024 from 9.00 a.m to 3.00 p.m, upon payment of a nonrefundable tender fee of Rs. 2500/= (Including VAT) for each document at the Chief Engineer (Projects) Office, Road Development Authority, No. 04, Bandaranayaka Mawatha, Ratnapura.
- The Bid Security shall be a bank guarantee from a reputed bank in the name of Provincial Director (Sabaragamuwa), Road Development Authority, Ratnapura for the amount stated above table and it should be valid upto 17th July 2024. Any Bid not accompanied by a valid Bid Security will be rejected.**
- The successful bidder shall submit a Performance bond as per the specimen for the value of 5% of the award from a Bank in Sri Lanka, acceptable to the RDA..
- Contractor who pay VAT, must state the VAT number and attach a copy of the VAT registration certificate with the bid document.
- Sealed Bids, addressed to Chairman, Regional Procurement Committee, Chief Engineer (Project) Office, Road Development Authority, Bandaranayaka Mawatha, Ratnapura be dispatched either be sent by registered post or be deposited in the Tender box kept in the office of Chief Engineer (Project), Road Development Authority, Ratnapura at or before 02.00 p.m. on 03rd April 2024. **The Bid name shall be marked on the top left hand corner of the envelop. Tender do not so will be rejected.**
- All machinery (Bitumen Sprayer, Air Compressor, Paviour, static roller, PTR, etc...) required for laying and compacting asphalt concrete shall be provided by the contractor.
- Bids will be opened immediately after the closing of the Bids at the office of Chief Engineer (Project), Road Development Authority, Bandaranayaka Mawatha, Ratnapura. Bidders or their authorized representatives are requested to be present at the opening of the bids.
- The late delivered Bids will not be accepted and returned to the bidder unopened.
- Bids shall be valid upto 19th June 2024.**
