4. It is **Mandatory for bidders to register under public contracts act no.03 of 1987**. For each contract (for contract value is more than 5 million) separately.

A complete set of bidding documents in English language may be purchased by interested bidders on the submission of written application, **registration form the Department of the Registrar of companies and CIDA** book to the **Provincial Director (NWP), Road Development Authority, Puttalam Road, Kurunegala** from 09.04.2024 until 22.04.2024 (only week days) from 9.00 hrs. to 15.00 hrs. upon payment of a non-refundable Tender fee (Above Table) for each document (Excluding VAT).
