1. The chairman, Road Development Authority Procurement Committee, on behalf of EOM&M Division of the Road Development Authority (RDA), invites sealed bids from eligible and qualified bidders for the works described below :-.

2. Bidding will be conducted through the National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall be currently registered with the Construction Industry Development Authority (CIDA) for **C3 or above grade in Highway Construction.**

The Pre-Bid meeting will be held at **13.15 pm** on **28.05.2024** at the office of the **Deputy Director General (Procurement), Road Development Authority, 04<sup>th</sup> Floor, Maganeguma Mahamedura, Denzil Kobbekaduwa Mw, Battaramulla** and a site visit will be arranged immediately thereafter if necessary.

A complete set of Bidding Documents in English Language shall be purchased by interested bidders on submission of a written application to the **Deputy Director General, Expressway Operation, Maintenance & Management Division**, Road Development Authority, Kahatagahahena, Walgama, Bandaragama from **09.05.2024** until **03.06.2024** during **09.00 hrs to 14.30 hrs** upon payment of a Non-refundable fee of **Rs. 27,500.00 + Government Taxes** for the contract. The method of payment will be in cash. As per the **Public Contract Act No. 03 of 1987**, the **Agent and Successful winners of the tender shall be registered in the Department of Registrar of Companies.**
7. Each Bid shall be accompanied by a Bid – Security obtained from a reputed bank acceptable to the Employer for an amount given in the Bidding Data. **Bid – Security shall be valid until 01.10.2024.**
