- 6 It is Mandatory for bidders to register under public contracts act no.03 of 1987. For each contract (for contract value is more than 5 million) separately.

Bids will be opened soon after closing.
- 9 Bids shall be valid up to 16/10/2024.
- 10 All bids shall be accompanied by a Bid Security as mentioned in the above table and it shall be valid up to 13.11.2024.
