## INVITATION FOR BIDS

**INVITATION FOR HIRING OF VEHICLES ON WET LEASE BASIS TO THE EXTENSION OF SOUTHERN EXPRESSWAY (FROM GODAGAMA TO MATTALA) OF EXPRESSWAY OPERATIONS, MAINTENANCE AND MANAGEMENT DIVISION FOR ONE YEAR PERIOD-2023/2024**

1. The Chairman, Expressway Operations Maintenance & Management (EOM&M) Division's Procurement Committee, on behalf of the Road Development Authority (RDA), invites sealed bids from eligible and qualified bidders for the above procurement under **National Competitive Bidding** (NCB) procedure.
2. The total requirement of the supply under the above procurement is as follows for the vehicles on wet lease basis (with Driver and Fuel).

3. Bids must be accompanied by a bid security for each vehicle as given in the above table valid up to 08/09/2023. The Bid Security shall be in a form of an unconditional guarantee obtained from a reputed organization approved by the Central bank of Sri Lanka in favor of the Director General, Road Development Authority, No. 216, "Maganeguma Mahamedura", Denzil Kobbekaduwa Mawatha, Battaramulla. Any bid not accompanied by a valid Bid Security will be rejected.
4. A complete set of Bidding Documents may be purchased by interested bidders from the office of **Director (EOM&M Division), Road Development Authority, Kahatagahahena, Walgama, Bandaragama** or **Additional Director (EOM&M Division), Road Development Authority, Kahawatta, Beliatta** on submission of a written application until 11/05/2023 during 09:00 a.m. to 2:30 p.m. on weekdays except for mercantile holidays upon payment of a non-refundable fee of Rs. 1,200.00 (Inclusive of VAT & SSCL). The method of the payment for document fee shall be in cash. Bidding documents may be inspected free of charge at the above offices during office hours.
5. Sealed Bid may be dispatched either by registered post or hand delivered to the **Additional Director (EOM&M Division), Road Development Authority, Kahawatta, Beliatta**. The bids will be closed at 2.30 pm on 12/05/2023. **Late bids will not be accepted.** The bids will be opened immediately after the closing of bids. Bidders or their authorized representatives will be allowed to be present for the bid opening event.
