A complete set of Bidding Document in English language shall be purchased by the interested bidders via email on submission of a written application and valid cash deposit slip of non – refundable tender fee (contract number and name of the contractor should be indicated on the cash deposit slip) to Director (Construction), RDA via email from **28.06.2021** until **26.07.2021** during **09:00 hrs** to **15:00 hrs** for each contract.
