5. **Each Bid must be accompanied by a Bid security (Valid up to 09.10.2023) obtained from a reputed Bank acceptable to the Employer for an amount given in the above table. Any Bid not accompanied by a valid Bid Security will be rejected.**
6. All pages of the bidding Document shall be initialled by the bidder and required to place his official seal.

Complete set of bidding documents shall be purchased by interested bidders on submission of a written application to the **Director, Procurement Division, Road Development Authority, 4th floor, “Maganeguma Mahamedura”, No. 216, Denzil Kobbekaduwa Mw, Koswatta, Battaramulla from 28.04.2023 until 19.05.2023 during office hours on 9:00 a.m. to 3.00 p.m.** upon payment of a non-Refundable Tender fee of **Rupees. 3450.00 (Inclusive of VAT) per each document** by depositing to the **Bank of Ceylon – Corporate Branch Account Number 0000001943 in favor of Director General, Road Development Authority for contract. The original payment slip should be produced when purchasing the Bid Documents.** As per the public contract act.no.3 of 1987, the agent and successful winners of the tender shall be registered in the Department of Registrar of companies. **Bid received will be closed at 2.00 p.m. on 22.05.2023.**
