

Sales of Used Tyres & Empty Tar Barrels

Interested parties are invited to offer quotations for purchase of used tyres & empty tar barrels available at the premises / Province specified in annexed tender forms.

Prescribed tender forms are annexed herewith and the closing date of Application is on 08/08/2023 at 10.30 am. These items can be inspected during the period starting from 17/07/2023 9.00 am to 2.30pm on 07/08/2023 at the location specified in the schedule.

Sealed quotations should be sent through Registered post to Director Finance, Finance Division, Road Development Authority, 2<sup>nd</sup> floor, Maganeguma Mahamedura, Denzil Kobbekaduwa Mawatha, Battaramulla. On or before 1.00 pm on 08/08/2023 or deposited in the tender box available at the above address on or before mentioned time above. The top left-hand corner of the envelope containing tenders should be clearly marked "Tender for sales of Used Tyres / Empty Tar Barrels and Location as per mentioned in the Tender forms.

Tender Forms will be issued up to 10.30am 08/08/2023.

*Specified & General Conditions*

1. Tender documents will be issued on payment of non-refundable tender fees of Rupees 2,000/- (Inclusive of SSDL & VAT) at the address above or by the respective Accountant in each of the province category and Extension of Southern Expressway -EOM&M Division with a written request and separate tender form should be submitted for each location and each category mentioned at the tender forms.
2. At the submission of tender forms Rs.25, 000/- should be paid as refundable deposit for each location separately, It can be made by cash or Bank draft, If payment is made by a bank draft it should be drawn in favor of Director General Road Development Authority & valid until 90 days. (If bank draft is not valid 90 days that tender will be rejected.) If payment is made by cash to the Shroff at above address or to the respective Accountant in each of the province, with the receipt No and date should be mentioned in the tender forms at the appropriate place.

3. The payment of refundable deposit will be made after completion of tender processes and if a successful Tenderer does not make the payment for purchase items, of the refundable deposit will be forfeited. Successful Tenderer should remove the items from the premises within the ten working days.
4. The Tenderer should be filled with all details requested in the tender forms (Name should be mentioned as National Identity Card) and should be signed by the Tenderer. (If official seal available should be franked) In completed tender forms will be rejected. (A clear copy of National Identity card or Driving License should be attached)
5. Tender prices will be evaluated separately for each place. All quoted tender prices will be subject to Social Security Contribution Levey (SSCL 2.50%) and Value Added Tax (VAT 15.00 %.)
6. The Tender forms for each category and each province/office should be submitted separately as per details given in annexed tender forms.
7. The Tender will be open on 08/08/2023 at 1.00 pm and tenderer or his agent can be participated at the tender opening session.
