Since the Total Cost Estimate of the procurements of Items are below 50Mn, Regional Preference and CIDA grade preference shall be apply as stipulated in Public finance Circular No:04/2016(11) and 5% preference will be given to state owned Enterprises at the financial evaluation as Public finance circular No: 03/2020(1).
2. To be eligible for contract award, the successful bidders shall not have been blacklisted and shall be currently registered with the bridges at Construction Industry Development Authority (CIDA) as given in the above table.
