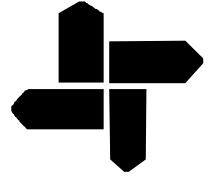

**NOTICE OF AWARD**

1. The Government of Sri Lanka has received a loan of US\$ 40 million from the OPEC Fund for International Development (OFID) for the Miscellaneous Foreign Aided Project (MFAP) to improve Rakwana- Suriyakanda Road. There is a loan balance after completion of original scope of the loan and proposed to Rehabilitate and Improve Walgama - Diyagama road in Colombo District.
2. The Road Development Authority ("the Employer") invited separate sealed bids on International Competitive Bidding (Single Stage One Envelope) procedure from eligible bidders for the said project. Eight Bids were received at the deadline for submission on 17<sup>th</sup> May 2024 at 14.00hrs for the above Contract package. The bidders who have submitted complete bids along with bid prices were read out at the price bid opening held on 17<sup>th</sup> May 2024 and the evaluated bid prices are as follows.
